7. **Old Business:**

- a. Nominations for new CG Officers: 1 nomination came in for each office. Nominees were CMSgt Garland for President, CMSgt Taylor for Vice President, CMSgt Fischer for Secretary and CMSgt Jozwiak for Treasurer. Congratulations! The new officers will be sworn in at the end of next month's CG meeting – 28 Mar. **(CLOSED)**

8. **New Business:**

- a. Pay \$100 to support Angel Volunteer Awards (add to annual budget). A motion was made to add Angel Volunteer Award to annual budget. Motion tabled for future vote due to nature of what funding is actually supporting. Will it be to sponsor an actual award or will it go to fund general operating costs of event. **(OPEN)**
- b. Sponsor Gunter NCOA Levitow Award. Request pulled back by CMSgt Norman. No vote required. **(CLOSED)**
- c. Consider reducing number of CG CCAF Scholarship from 4 to 2 or 3. Motion to change to 1 x Knute Horn Scholarship at \$200 and 2 x CG scholarships at \$100. Motion approved. Upcoming selection committee will consist of our new council and an AFA Representative. CMSgt Sanders will help facilitate. **(CLOSED)**
- d. A motion was requested by CMSgt Reynolds to help Airman's Attic fund postal costs to ship packages to deployed Maxwell-Gunter Airmen on a quarterly basis. CMSgt Sanders stated a budget analysis needed to be conducted by Treasurer to determine if

we can support every quarter. That analysis will be provided by the Treasurer at the next meeting. In mean time the group voted to provide \$200 this first quarter. The vote to fund this quarter was unanimously in favor. The original motion is still open until we determine if we can support this long term or not. **(OPEN)**
